Total income for August was \$6,278.52 Donations were \$4,026.99. August expenses were \$5,988.36. We have a total of \$18,955.48 in cash and \$9,118.40 in book inventory for total assets of \$28,073.88. Note the correction to the Checking Account total for July. Founders Day expenses have been finalized and posted on the web site. Rent (including parking) for new location is approximately \$400.00 more than Palama Settlement. We were getting a very good deal at Palama. The 2015 Budget is approximately \$101,685, an increase of \$5,644.4 over projected 2014 expenses. The increase is primarily due to the increase in office rent. Rent budgeted does include fee for meeting space at Palama Settlement. Budget for Activities includes Founders Day, Homegroup Day, etc. Bank fees are for special services like changes to signature cards. These are not fees for checking/savings accounts.
