**Reports:** 

<u>Chair, Kalae</u> H: Went to International Convention for the first time. It was awesome, amazing!

<u>Treasurer, Elise C</u>: June Profit and Loss: we had an outstanding month; we had over \$5,000 in contributions thanks, in part to several groups contributing this year for the first time. Groups making their splits is essential. We had great participation in Founders' Day and sold a lot of T-shirts and lunch tickets and came way ahead. Over a period of a few months the gross income was \$6,443.68 (doesn't include expenses). Keola, her group, and Patti did an outstanding job. We ended up, for the first time this year, in the black, so let's keep that going. Please also refer to the group contributions, which includes only groups that have made contributions this year. Then we have the Balance Sheet that reflects our bank accounts. We are working out some kinks in our QuickBooks program trying to find out what the Accounts Receivable is. Inventory Assets is the Book Bank, so we have total Assets of \$17, 030.80.

<u>Central Office report, Jamie-Central Office Manager</u>: Central Office had 819 calls, including requests regarding meetings (510), literature orders (291), and 12-Step Calls (6). We had 47 visits for literature sales (32), Information about A.A. (13), and 2 12-Step Calls. Central Office is always looking for volunteers and after-hours phone angels, but we do have all time slots filled! Area committees are looking for interested volunteers for Public Information and for Cooperation with the

Professional Community, especially to lead DUI class presentations or members interested in being speakers. REMINDER to groups to let CO know when there are meeting changes in location or time, especially for the holidays. We have renewed our meeting lease with Palama Settlement for the Lanai Area in order to save money. The sales pricing on selected literature [that was available at Founders' Day] has been extended until those items are sold out. The lowered price is 25% off and is below our cost and includes some Grapevine books and the commemorative issue of our Big Book. Current projects include work on the IG archive, update of meeting registration information, general paperwork organization.

## Vice-chair/Activites Report, Josh T:

1. Bill & Lois Dinner: at the August meeting we will come with tickets. We are working on the budget, and our target date in September 26. The event may cost \$48 per ticket and will be dressier event at a hotel. <u>Dayna, Chair</u>: There will be a theme (e.g. 1930's Hawaii) with Aloha attire. It will be at The Airport Plaza sister hotel in the ballroom, which will be free with the order of a set menu. The more people that buy tickets, the better the menu will be.
