<u>Treasurer-Elise:</u> total income for December was \$5,889.13; contributions were \$4,570.63; December expenses were \$2,966.20 leaving net gain at \$2,922.93; we have total funds of \$6,769.36 (\$4,768.76 in checking and \$2,000.60 in savings) and literature inventory of \$1,994.95; we need to build up our Prudent Reserve; Holiday Dinner was a success with over \$900 in net proceeds

In 2016 we will be paying salary and related expenses; we will also have to pay 6,127.05 in Federal payroll taxes, penalties, and interest for 4^{th} quarter 2014, 1^{st} and 2^{nd} quarters in 2015 payments not were not previously and penalties, etc. for payroll reports not filed; so we still have a dire need for your group contributions

Mahalo to all the groups and individuals for their generous contributions received in 2015. We managed to come out in the black by over \$9,000 for the year, bearing in mind the above taxes not paid.

<u>Central Office Report-Adina, Central Office Manager:</u> thanks to all the folks who kept the office open and running; during December, Central Office had 86 visits and 310 calls including 11 12-step calls, 167 for meeting times and locations, 100 for general information and 23 requests for literature

We want to update group information; Central Office requests an upright vacuum cleaner and carpet cleaning; there are open volunteer slots and phone angel slots; would like to expand coverage of all shifts to 2 people per slot, and we will be having volunteer meetings and orientation; the first volunteer meeting will be February 6 after 3:00; we will be closed on 1/18 for MLK Day and 1/30 due to interruption in electricity for the building; we have 2014-2015 Service Manuals and T-shirts from 2014 Founders' Day

<u>Vice-chair/Activities Report-Josh T:</u> in 2015 we had Home Group Day, Founders' Day, Bill & Lois Dinner and the Holiday Dinner; will be doing the same events in 2016; except for Founders' Day, we need events chairs-qualifications were read
