• Discussion and adoption of the OIG 2018 Budget:

Discussion: Hang Loose concerned that Activities keeping OIG a float, feels salary should not be raised, needs to stay within our means with travel expenses and employee training. Na Wahine O Koolau cannot vote on a budget operating on a negative feels parking is an excessive expense, people visiting Central Office can use Public Parking. Central Office Manager explained contributions have been down so we have had more events and basically events have kept Intergroup a float. This increase in salary was because the Manager was working more than 20 hours per week so the board bumped up her hours to 30 per week on September of 2016. The board felt Adina was doing an excellent job and increased her salary 7% starting in 2018. The paid parking space was given back saving money on parking. Historically when Intergroup has had a budget it has been operating in the negative. When Adina started we did not have a budget. The budget has a priority of spending.
